- 4. Do not submit original work to jury. Only JPEG's on CD or USB will be considered. No slides or photographs, please. JPEG images should be no larger than 3mb in file size. A maximum of 3 works of art may be submitted. Up to 3 views of three-dimensional works may be submitted.
- 5. Image files must be named with a number at the beginning of the file name (eg: lartworkname.jpg). A corresponding printed list of files should accompany the CD/USB and include for each piece the artist's name, title, date and size of work.
- 6. A non-refundable fee of \$25 for artwork entered (for a maximum of three works) must accompany the entry form. This will also cover your membership at the Minto Arts Council. Please make cheques payable to the:
