Faith Hieblinger has participated in exhibitions as curator, juror and artist throughout Southwestern Ontario and beyond. She spent close to three decades as Executive Director/Curator of the nationally recognized Homer Watson House and Gallery. She has also curated shows with the Etobicoke Art Gallery and Art Gallery of Mississauga and is affiliated with City of Kitchener as guest curator in the Berlin Tower ARTSPACE. Hieblinger has enjoyed working with Studio Art Quilt Associates international or SAQA, curating an exhibit that is currently touring across Canada. Her own artwork is exhibited with the Art District Gallery of Waterloo Region. Hieblinger is an award winner for excellence in heritage arts and two-time nominee for the Kitchener Waterloo Arts Award. She studied Business at Wilfred Laurier University and has an honours fine art studio degree from University of Waterloo.

## Conditions of Entry

1. This call for entry is open to all artists living in Ontario.
2. All works submitted must have been completed within the last five years and must be original works. Visual arts submissions can include either 2 or 3 dimensional art in multiple disciplines and mediums.
3. Due to limited available space in the gallery, the following dimensions are suggested:

- For two dimensional pieces, the longest dimension should be no greater than 24 inches;
- For sculptures dimensions should be no greater than $36^{\prime \prime} \mathrm{H} \times 20^{\prime \prime} \mathrm{W} \times 20^{\prime \prime} \mathrm{D}$

4. Some consideration may be given to slightly larger pieces, however, this will be at the discretion of the Minto Arts Gallery and will depend on available space.
5. Please submit your entries as follows: a jpeg image via email julianeavw@icloud.com. A maximum of 3 works of art may be submitted per entry.
6. Image files must be named with a number at the beginning of the file name (eg:1 artworkname.jpg). Please include for each piece the artist's name, title, date, size of work and whether the piece is for sale and the price.
The Jurors will review the digital submissions received in order to short list the entries to be included in the show. This means that not every item submitted will be included in the show.
7. A non-refundable fee of $\$ 30$ for artwork entered (for a maximum of three works) must accompany the entry form. This will also cover
